

# SCBA State Fair Booth (2018)

---

*The following is from the SCBA State Fair Booth Rules (2016) and adapted to provide additional information.*

## **Seller's responsibilities are to:**

- A. Remember selling honey is a privilege and not a right and that you are representing the SCBA.
- B. Coordinate with Gate Guards and building personnel for instructions for unloading your goods. You will be mailed a free parking pass October 1. This pass is for Gate 11 off Bluff Road. Parking spaces are not assigned and cover one vehicle and all its passengers. You will be required to stop at the Gate to verify with Personnel that you have the correct pass and are headed to the Ellison Building. You may pull up to the back door. If not propped open, bang on the door, and the designated Building Personnel will direct you on unloading where to deposit trash, etc.
- C. **Sell only South Carolina bee products produced by Seller.** (The only exceptions are honey sticks and honey candy.) **NO BOOKS OR EQUIPMENT.**
- D. Provide an observation hive that is representative of a healthy hive with a marked queen for the day(s) he/she sells. Ensure the base of hive is clean and keep tablecloth clean for next seller. It is suggested that you bring a tablecloth to cover only the top.
- E. Sell honey from the time the doors open until the doors close.
- F. Have a minimum of 2 and a maximum of 3 people selling at all times.
- G. Have a minimum of 300 pounds of honey to sell at the beginning of their shift. Honey must have State-approved labeling.
- H. Display goods on a maximum of one 8-foot table and 3-feet of the second table. Do not place personal items on exhibit display shelving. Store excess product, supplies, and personal items under table. Please place honey sticks away from the observation hive (People try to pay the education volunteers, and they are not to handle transactions.)
- I. Donate 2 labeled pints of honey for State Fair personnel and South Carolina Department of Agriculture cooking demonstrations. This also must have State-approved labels. A crate at the back of the booth is provided for your donation, which is required by the Fair. Please do this **first thing**. There is a crate at the back of the booth.

## **Seller's responsibilities are to:**

- J. Meet the following considerations in order to sell honey:
  - a) Be an active member of the South Carolina Beekeepers Association;
  - b) Have a minimum quantity (300 lbs.) of honey to sell;
  - c) Abide by the rules approved by the SCBA Executive Committee and the South Carolina State Fair Association;
  - d) Submit a written request to the SCBA Booth Coordinator by August 30<sup>th</sup> to be added to the potential sellers list. Every effort will be made to accommodate your request. No more than one day will be assigned initially. Vacancies will be filled to further accommodate requests. Any duplicate requests will be filled via lottery. Once notified of your assigned date, reply to Booth Coordinator stating:

*I agree to abide by these rules as approved by the SCBA Executive Committee.  
If I see that I will not be able to sell honeybee products, I will contact the Booth Coordinator immediately.*
